AGGREGATE FOR BITUMINOUS SURFACE TREATMENTS:

At a minimum, the coarse aggregate for bituminous surface treatments shall be crushed aggregate meeting the requirements of ALDOT Standard Specification for Highway Construction, latest edition or special provision, Section 801. In addition, the material shall meet the requirements of the Chambers County Engineer for use in a Freightliner RA-300 Patcher. The stone shall be washed, clean, and suitable for use in this machine. Material shall be inspected by the County Engineer, or his representative, and deemed suitable for use. It is at the Engineer's discretion which stone is best suitable for the County's use. **ALL APPLICABLE TAXES AND FEES SHALL BE INCLUDED IN THE BID PRICE PER TON FOR EACH ITEM. NO ADDITIONAL FEES, TAXES, OR SURCHARGES WILL BE PAID BY THE CHAMBERS COUNTY COMMISSION.**
