BULK CEMENT

All materials shall meet the current requirements given in Section 815 of the current ALDOT specifications for Type I or Type III Portland Cement and /or approved by the Chambers County Engineer. Chambers County shall be allowed to pick up the material at the site of the bidder's concrete plant. Bid Price shall include the furnishing of the Portland Cement from a Silo or similar storage device at said plant to Chambers County equipment. Chambers County will be required to furnish a device adapted to supply the cement in a manner that avoids waste. Bidder shall be able to supply the cement within 24 hours of notice. For Bidding purposes, Chambers County estimates up to 5 Tons per purchase order.
