Price to include two (2) lifting lugs per pipe.

Please list price per foot and price for corrugated bands for round and arch metal culvert pipe. **Round** from 12" to 120", 16 gauge to 8 gauge. **Arch** from (span x rise) equivalent to 12" to 120" round pipe sizes from 16 gauge to 8 gauge.
