**Specifications:**

General: These specifications shall be construed as the minimum acceptable requirements for fuel delivery to the Chambers County Highway Department: Deliveries of gasoline or diesel fuel will be delivered as called for by the County Engineer in loads of 8,000 gallons or more. Gasoline may be 87 octane, equal or better commodity with up to 10% Ethanol included. Diesel fuel shall be grade #2, with a minimum cetane index of 46, equal or better commodity. Chambers County reserves the right to award this bid as a whole or divide it into two separate sections. The Chambers County Highway Department will require copy of the rack pricing to be given each time there is a fuel delivery to any of our locations. Invoices shall include the following itemized: Rack Price, Taxes/Fees, and Delivery Price.

**Bid Price:**

Chambers County requests that the bidder submit the delivery price per gallon, ONLY, as the Bid Price. This price shall include destination charges, delivery charges, fees, rebates, surcharges and all other applicable costs and refunds. This price shall exclude the applicable taxes and fees, listed below, and the current Rack Price.
