

PUBLIC NOTICE

Pursuant to Resolution Numbers 11-2-15.1, 11-2-15.2, and 11-2-15.3 of the Chambers County Commission, certain polling locations have either been relocated or consolidated.

Wherefore according to Resolution No. 11-2-15.1, citizens who have previously voted at the voting precinct known as the "Chambers County Courthouse", it is now known as "City of LaFayette Voting Precinct" and **you will now vote at the LaFayette High School Gymnasium** located at 214 1st Avenue SE, LaFayette, Alabama, instead of the Chambers County Courthouse in LaFayette. This will affect all precincts previously voting at the Chambers County Courthouse, more specifically Precinct Numbers 801.01, 801.02, 802.01, 804.01, 804.02, 805.01, 805.02, 806.01, 807.01, 808.01, 808.02. These precinct numbers will remain the same. This change will be for all future county, state, and federal elections beginning immediately. This will not affect any city/municipal elections.

Wherefore, according to Resolution No. 11-2-15.2, citizens who have previously voted at the Huguley Water, Sewer, and Fire Protection Authority Fire Department (a.k.a Huguley Fire Department) location both in the Huguley Lions Club Voting Precinct and the Rescue Squad Voting Precinct **will continue to vote in the same location**. This resolution consolidates these two precincts into one. The Huguley Lions Club Voting Precinct and the Rescue Squad Voting Precinct will now be corporately be known as the Huguley Voting Precinct. This will affect the following Precinct Numbers 721.01, 721.02, 722.01, 723.01, 724.01, 724.02, 725.01, 1341.01, 1341.02, 1342.01, 1342.02, 1343.01, 1344.01, 1345.01, 1345.02, 1346.01, 1346.02, 1347.01, 1348.01, 1348.02. The new precinct numbers are contained below. This change will be for all future county, state, and federal elections beginning immediately.
