PRICE ADJUSTMENTS will be made in accordance with the following: It is understood and agreed that the price per square yard of surface treatment is based on prices at the time of opening of bids. Prices on contracts developed from this bid will be adjusted based on the PRICE INDEX per gallon of asphalt as determined by the ALDOT Asphalt Index for the month of August 2015. Any increase or decrease in asphalt prices will be determined and adjusted by the price index for the month in which delivery and placement is made. Adjustment will be made in accordance with the current ALDOT Specifications. This adjustment shall apply to the amount of liquid used in the Surface Treatment.

Contractor shall furnish flagmen and portable traffic control devices (or other method approved by the County Engineer) in accordance with the Manual of Uniform Traffic Control Devices.

Work shall begin within 14 Days of Written Notice from Chambers County Hwy. Dept., unless a time extension is given by the County Engineer. In the event that Work has not commenced within the allowable time frame as stated above, the purchase order may be cancelled and placed with the Contractor whose price is the next acceptable bid above that awarded. Contractor shall give Chambers County twenty-four (24) hour notice that work is to begin. Notice shall be given during the normal hours of operation of the Chambers County Highway Department.

If mutually agreeable, the bid may be extended for up to three (3) years, in one (1) year increments.

If you are unable to furnish an item as specified and desire to offer a substitute, please give full description of the items offered as substitutes, otherwise your quotations will not be considered. If no exception is made on bid sheet, it will be assumed that the bidder is offering the articles specified. Bidders must indicate the brand or make of items they propose to furnish.

Signature on bid must be in ink. Bids made out in pencil will NOT be accepted. Bid must be NOTARIZED. County reserves the right to accept or reject all Bids or any portion thereof.
